President's Report:

Vice President's Report:
Nothing to report.

Treasurer's Report:

2014 taxes finally filed. The necessary information has been given to our former accountant three times, and had not been done until now. This caused a hiccup in our standing with the Secretary of State, which caused a delay in getting our liquor license renewed. This has now been corrected by our new accountant, with great assistance from Hali Loving and Maynard Cowan. The club is back in good

standing. Our liquor license is being pushed through, according to Charmaine Martinez, our contact at Alcohol and Gaming.

We've had two fantastic parties this month, both the wrap party with Villa Capri, and the GPG art show, both of which were very profitable. The Villa Capri party was a huge success, and much larger than expected, due to the presence of Morgan Freeman.

Water costs are still high, however, we increased liquor sales by \$2000 over last year, with an increase in liquor costs of only \$60.

Steve Satchwell moves that we authorize Hali to solicit bids to fix the heater, with the concurrence of the Executive Committee. Seconded by Ken Hargis. With no objection, the motion carries.

Old Business:

Constitutional amendments are under discussion. Changes to Article 3, Section 3, have been withdrawn.

Steve Satchwell moves that we discuss proposed changes to the APC Constitution. Seconded by Rhian Hibner. Discussion of changes to the document ensued.

New Business:

Rhian Hibner moves that we allow for virtual presence of Board Members by means of real-time communication. Seconded by Frank Serriani.

Discussion of potential constitutional changes that this motion may need, requires a return to Old Business.

Back to Old Business:

Discussion of constitutional changes continues. Steve Satchwell will create a packet for consideration by the general membership. Changes will be officially proposed and voted on at the annual meeting.
